RULES OF THE CAMPAIGN

“BONUS OF CZK 1,000” FOR ARRANGING THE SUPPLEMENTARY PENSION SAVINGS

1. Campaign Promoter and Organiser

KB Penzijní společnost, a. s., with its registered office at Prague 5, Nám. Junkových 2772/1, Postcode: 155 00, identification number (IČO): 61860018, registered in the Commercial Register administered by the Municipal Court in Prague, file no. B 2865 (hereinafter “KB PS”).

2. Campaign Duration

The campaign shall take place from 1 March 2021 to 31 May 2021 (hereinafter the “Campaign Duration”).

3. Participation in the Campaign

All new participants of KB PS are eligible to take part in the campaign – individuals over the age of 18, who are not “foreign nationals” within the meaning of Section 1(1) of Act No. 326/1999 Coll., and who enter into a Contract on Supplementary Pension Savings (hereinafter the “SPS Contract”) with KB PS using the Mobilní banka KB app throughout the Campaign Duration (hereinafter the “Campaign”).

4. Bonus and Terms and Conditions for Awarding the Bonus

With regard to the conclusion of SPS Contracts, KB PS shall provide the participants with a bonus of CZK 1,000 (hereinafter the “Bonus”), to be credited to newly concluded SPS Contracts.

Each Campaign participant shall receive the Bonus, subject to the following terms and conditions:

- a) Campaign participant enters into an SPS Contract with a signature date of no later than 31 May 2021, paying the first agreed monthly contribution of no less than CZK 500 to such SPS Contract no later than 31 January 2022 (and such participant’s own monthly contribution of no less than CZK 500 must be contractually agreed); and
- b) SPS Contract is accepted by KB PS, i.e. the relevant contract is registered and KB PS sends a confirmatory letter/email to the given participant.

5. Deadline and Process for Crediting the Bonus

KB PS shall provide the Bonus to be used by participants as their own contributions to their SPS Contracts. The Bonus shall be considered a special contribution of the participant (notified in advance) for the month, in which it is credited. The Bonus shall be paid within 2 months after the fulfilment of all the terms and conditions specified in Section 4.
