We are entitled to charge a fee due on the 5<sup>th</sup> Business Day of the following month and debit your account by the last day of that month at our discretion.

### **General Provisions**

- The fees for the banking services are collected in CZK and settled in the account currency or in the account main currency (on the case of Multi-Currency Accounts). The fees will be converted using the current KB mean rate. The amount of the fees collected in cash in CZK shall be rounded to the nearest valid denomination of legal tender money in circulation.
- 2. Unless specified otherwise in a particular case, we shall start charging the fee for the tariff from the next succeeding day after you have chosen it. The tariff fee, or a pro rata portion thereof, shall be payable on the last day of the calendar month for which it is charged, unless otherwise stated. If the tariff is changed during the month, the pro rata portion of the fee for the original tariff shall be payable at the date of such change while the pro rata portion for the new tariff shall be payable on the last day of the calendar month for which it is charged. If, for any reason, the process of cancellation of the last account under the tariff is initiated, the pro rata portion for the calendar month in question shall be payable at the date on which the cancellation of the last account is initiated and the tariff charge shall no longer be charged from that date. Unless we agree otherwise, we may debit the tariff fee from any of your accounts as we choose (we shall generally debit it from your oldest current account held under the tariff). You can find out which account we shall debit the fee from in the KB+ mobile or web app, where you can also change the selection of the account.
- 3. Where the term 'price', 'charge' or 'reimbursement' is used in the respective contracts for the provision of services entered into by and between us, it means the fee as set out in this Pricelist of Products and Services.
- 4. Unless we agree otherwise with you, we shall provide you with products and services not listed in this Pricelist of Products and Services or free.
- 5. The Bank accepts coins only in CZK.

This Pricelist of Products and Services shall take effect as from 1 May 2025 and shall repeal and replace the Pricelist of Products and Services effective from 1 February 2025.
