SEPA PAYMENTS FOR THE SAME PRICE AS DOMESTIC PAYMENTS

By equalizing the fees for incoming and outgoing SEPA payments with those for domestic payments, the basic mission of SEPA has been fulfilled, i.e. any borders have actually been eliminated in respect of making payments and direct debits in EUR within and between SEPA countries. From now on, we will charge you the same prices for incoming and outgoing SEPA payments as for domestic payments (i.e. payments made in CZK within the Czech Republic).

When are the fees going to change?

Starting from 15 December 2019, the fees charged to all clients of KB belonging to all segments will be substantially reduced.

The fee reduction applies to the following payments:

- Outgoing and incoming SEPA payments (including payments made under SEPA standing payment orders),
- Payment credited and debited via SEPA Direct Debit,
- Establishing, changing and cancelling a SEPA standing payment order or SEPA Direct Debit mandate.

How are the fees going to change?

The limit of EUR 50,000 will no longer apply to incoming and outgoing SEPA payments. The SEPA payment fee will therefore be the same, notwithstanding the amount of the payment. The newly introduced SEPA payment fees and SEPA Direct Debit fees are shown below.

Have you got an account with preferential fees charged for domestic payments?

If incoming and outgoing domestic electronic payments, or incoming domestic payments, are provided for free along with your account, you will also have free incoming and outgoing SEPA payments or, as the case may be, incoming SEPA payments. It depends on the type of the account you use and the transactions that are part of it.
