**Client's Consent to the Delivery Method for Pre-Contractual Information and Conditions**

I hereby agree that Pre-Contractual Information and Conditions relating to any **Insurance Product** and **Insurance-based Investment Product** may be delivered to me in electronic form; moreover, I agree that the Bank may use the Contact Email for the purpose of communicating with me in connection with Pre-Contractual Information and Conditions.

I hereby agree that I may be notified of any change to Pre-Contractual Information and Conditions via email.

I am aware of the fact that I have an opportunity to receive Pre-Contractual Information and Conditions in paper form; however, I chose to receive them in electronic form – i.e. on another durable medium agreed with the Bank or via the website.

***I hereby declare that the Internet address and details regarding specific location of the relevant information at the said address have been disclosed to me.***

I give my consent for the period starting with the moment such consent is given until the termination of the last contractual or any other legal relationship between me and the Bank or between me and the Insurance Company, as appropriate.

I am aware that:

- a) The aforementioned consent to the delivery method for Pre-Contractual Information and Conditions is voluntary and I may withdraw it at any time. The withdrawal of my consent must be in writing; and
- b) I may always request Pre-Contractual Information and Conditions in paper form.

For the purpose of this consent, any capitalised terms used herein shall have the following meaning:

**“Bank”** shall mean **Komerční banka, a.s.**, with its registered office at Prague 1, Na Příkopě 33/969, Postcode: 114 07, identification number (IČO): 45317054, registered in the Commercial Register administered by the Municipal Court in Prague, section B, entry no. 1360.

**“Contact Email”** shall mean an email address you communicated to the Bank for the purpose of electronic communication, including any address notified at any time in the future. Moreover, Contact Email shall also mean your data mailbox set up in the MojeBanka internet banking application or any similar internet banking application of the Bank.

**“Insurance Company”** shall mean Komerční pojišťovna, a.s., with its registered office at Prague 8, Karolinská 1/650, Postcode: 18600, identification number (IČO): 63998017, registered in the Commercial Register administered by the Municipal Court in Prague, section B, entry no. 3362, as well as other insurance companies, whose products the Bank distributes.

**“Insurance-based Investment Product”** shall mean Packaged Retail & Insurance-based Investment Product (PRIIP), i.e. an investment, including instruments issued by special purpose vehicles as defined in point (26) of Article 13 of Directive 2009/138/EC or securitisation special purpose entities as defined in point (an) of Article 4(1) of the Directive 2011/61/EU of the European Parliament and of the Council, where, regardless of the legal form of the investment, the amount repayable to the retail investor is subject to fluctuations because of exposure to reference values or to the performance of one or more assets which are not directly purchased by the retail investor; and

**“Insurance Products”** shall mean:

- a) **Insurance products** offered by the Insurance Company that the Bank is authorised to distribute, other than insurance-based investment products;
- b) **Insurance-based investment products**, i.e. insurance products that offer a maturity or surrender value and where that maturity or surrender value is wholly or partially exposed, directly or indirectly, to market fluctuations.

**“Pre-Contractual Information”** shall include (without limitation) the following documents:

- a) **Key information documents**, particularly key information documents prepared in compliance with Regulation (EU) No. 1286/2014 of the European Parliament and of the Council of 26 November 2014 on key information documents for packaged retail and insurance-based investment products;

- b) **Insurance product information document** prepared in compliance with Commission Implementing Regulation (EU) 2017/1469 of 11 August 2017, laying down a standardised presentation format for the insurance product information;
- c) **Information about insurance intermediaries, insurance company, and insurance**, as well as any other pre-contractual information prepared in compliance with Directive (EU) 2016/97 of the European Parliament and of the Council of 20 January 2016 on insurance distribution, and with other binding legal regulations that implement the aforementioned Directive.

“**Conditions**” shall mean insurance terms and conditions relating to Insurance Products that the Bank is authorised to distribute for the Insurance Company; together with an insurance policy, such insurance terms and conditions govern the contractual relationship existing by and between the Client and the Insurance Company on the basis of such insurance policy.
