

NOTIFICATION OF THE MOJEKARTA DESIGN

This Notification of the MojeKarta design (hereinafter the "**Notification**") is issued by Komerční banka, a.s. (hereinafter the "**Bank**") in compliance with applicable Terms and conditions concerning debit cards, Terms and conditions concerning personal credit cards, and Terms and conditions concerning business and corporate credit cards (hereinafter the "**Conditions**").

The terms defined in the Conditions shall also have the same meaning herein.

I. Terms and conditions concerning personalised design

Clients may only submit such designs (photographs, pictures) to www.mojekarta.cz that:

- Comply with the technical parameters specified at www.mojekarta.cz;
- They are authorised to use;
- Do not contain the below specified images, whereas Clients undertake to ensure this:
 - a) Pornographic, obscene, erotic or sexist motives, naked individuals, sexual or provocative or otherwise unsuitable motives or gestures;
 - b) War-related, violent or racist motives (wars, weapons, violence and threats, wounded individuals or dead bodies);
 - c) Motives with any prejudicial content (e.g. cultural, social, political, religious, etc.), illegal or socially unacceptable groups;
 - d) Motives of racial intolerance, motives conveying hostility, ridicule, or aversion;
 - e) Branded products or services, including abbreviations, acronyms or symbols, products protected by trademarks or registered marks;
 - f) Advertising and promotional motives or materials, business cards, etc., any offers, requests or demands;
 - g) Works of art protected by copyright (not older than 70 years);
 - h) State and national symbols, political motives, symbols, slogans, organizations, or parties;
 - i) Religious motives, symbols, slogans, organizations, or churches;
 - j) Images contradicting rules of card associations that could affect or complicate Card acceptance by merchants;
 - k) Images that pose risks to Card's security features;
 - l) Images that could result in adverse or hostile perception of the Bank's brand or the Bank's presentation in a ridiculous manner;

- m) Public figures, such as artists, athletes, scientists, politicians, etc.;
- n) Client's personal promotion (business cards, telephone numbers, email addresses, websites, photographs, identification photographs or other identification data);
- o) Motives, symbols, and logos of the Olympic Games or other sports competitions and events;
- p) Any writings, texts or unknown languages;
- q) Unicolor designs.

II. Other provisions

The term "Card" shall mean debit or credit card. The Bank may refuse to issue any Card, the design of which contradicts the terms and conditions specified in Article I hereof. The Bank may also refuse to issue any Card without cause.

The Bank may, at any time, suspend or cancel any services provided in connection with any Card, provided the Bank comes to know the design of the relevant Card contradicts the terms and conditions specified in Article I hereof.

Clients shall immediately indemnify the Bank for any damage the Bank might incur in direct connection with their design placed on the given Card.

III. Final provisions

This Notification comes into force and effect on 5 December 2017.
