Consent with the Processing of Personal Data for Marketing Purposes

As part of the KB Group policy of transparency, we think it is important that you know exactly how we process your personal data and for which purpose they are used. The data we shall process based on your consent shall include: your first name and surname, birth number (and also the trade name, company ID/IČO, and registered office address in case of business persons), date of birth, contact data, information about your solvency, creditworthiness and credibility, sociodemographic data, information about your using of products and services, information collected from applications for products and services, information collected from telephone calls and/or other interaction between you and us, balances in your accounts, transactions data, geolocation data, information collected from an Internet browser you use, and information/data that we process in order to comply with our legal obligations or to pursue our justified interests. We may receive the aforesaid information/data directly from you, from public sources (such as the information about your person you make public on social networks and on the Internet), from polls, surveys and user testing, and/or from collaborating third parties.

The purpose of processing the personal data shall mean offering products and services provided by the KB Group members and collaborating third parties, possibly also via electronic channels, as well as marketing processing, analysing, and profiling, with the aim of customizing our offer to your needs and enhancing the quality of the provided services.
