- ✓ The fees for paper payment orders placed at branches will be standardized, and the fee for orders entered via the KB Express Line will increase
- ✓ The fees for some cash services will increase

Starting on 1 December 2021, drawing a mortgage loan immediately after filing an application for the registration of the lien **will be free of charge.**
